Printable, glossy, white soft-PVC-self-adhesive foil with a permanent polyacrylate-adhesive coating on one side

Thickness of the foil without the self-adhesive coating: app. 0.11 mm Thickness of the foil with the self-adhesive coating: 0.13 mm \pm 20 %

Mass per unit area: app. 173 g/m²
